- Local Government Change Commission is looking into boundary reviews and the final report is due to the Minister in October.
- New election management system has been developed to assist with the 2020 local government and state government elections.

1.6 Independent Assessor

- The Office of the Independent Assessor has received approximately 1,100 complaints received to date.
- Presenting at Local Government Association Queensland Conference in Cairns next week.

1.7 Auditor-General, Queensland Audit Office

- New Strategic Audit Plan to be published on website by 31 December 2019.
- After putting together a workforce plan, the Audit Office will be moving to a new operating model and expect it to be in place by Christmas.

- Significant increase in numbers of requests and educational training sessions.
- Audit of Register of Lobbyists has been completed.
- Submitted Integrity Commissioner's Annual Report for 2018/2019 financial year.
- Future focus is looking to setup the Minister's Management Plans.
