General updates

1.1 Electoral Commissioner

- Recruitment process of senior management roles finalised.
- Recruitment of Returning Officers for local government elections progressing.
- Local government election to utilise new election management system and some capabilities of the current system.
- Two new electoral reform bills to be tabled.

1.2 Racing Integrity Commissioner

- Submissions for the review of the *Racing Integrity Act* 2016 (Qld).

1.3 Chairperson, Crime and Corruption Commission

- Procurement process for information technology.
- Preparation of submissions for Queensland Parliament Estimates Hearings.

1.4 Ombudsman

- Approx. 8,000 jurisdiction complaints with approx. 1,000 investigated.
- Legislation reform proposal.

1.5 Auditor-General

- Finalised strategic workforce plan.
- Report to parliament on Cyber Security tabled.

1.6 Independent Assessor

- Office has now been established and last financial year received over 900 complaints (466% increase in complaints).
- This has resulted in 160 investigations with 50 matters being prepared for Tribunal and 13 completed.
- Second edition of Insight report produced on 16 July 2019 which is to be published on a quarterly basis.
- Working with 'Resolve' regarding an upgrade which commenced last week.

1.7 Information Commissioner

- Tabled three audit reports in June including 10 years on self-assessment report.
- 10th anniversary campaign including Solomon Lecture in August.
- Experiencing record level demand for services.
- Upcoming workshop with Bill Eddy, High Conflict Resolution Institute.

1.8 Director, Legal and Operations, Integrity Commission

- Capacity for local government complaints decreased.
- Website updated.
